## Phase Descriptions

**Phase 1:** On Dec. 15th, 2016 the WCPHP Core Planning Team reviewed quantitative regional data, stakeholder meeting data from 6 counties, and hospital community survey data to choose top health issues to rate with this prioritization tool. Phase 1 Totals reflect the outcome and rank from prioritization during that meeting.

**Phase 2:** During the Dec. 15th meeting, the WCPHP Core Planning Team recognized that not all of the six health issues that were ranked with the prioritization tool were identified in all six county stakeholder meetings as priority health issues. Following the meeting, Katherine Melland and Margaret Wacker included a separate question to reflect the desire of the WCPHP Core Planning Team to choose issues that had regional consensus: "Is there agreement across all 6 counties that this is a priority?" As indicated in the prioritization tool instructions, if the answer was: Yes (all 6 counties agreed) received a score of 2 from each of the 9 participants for a total of 18 points. Somewhat (4 or 5 counties) received a score of 1 for each of the 9 participants for a total of 9 points. No (3 or fewer counties) received a score of 0 for each of the 9 participants for a total of 0 points. The Totals column reflects the outcome and rank from the prioritization meeting and the additional regional consensus question.
