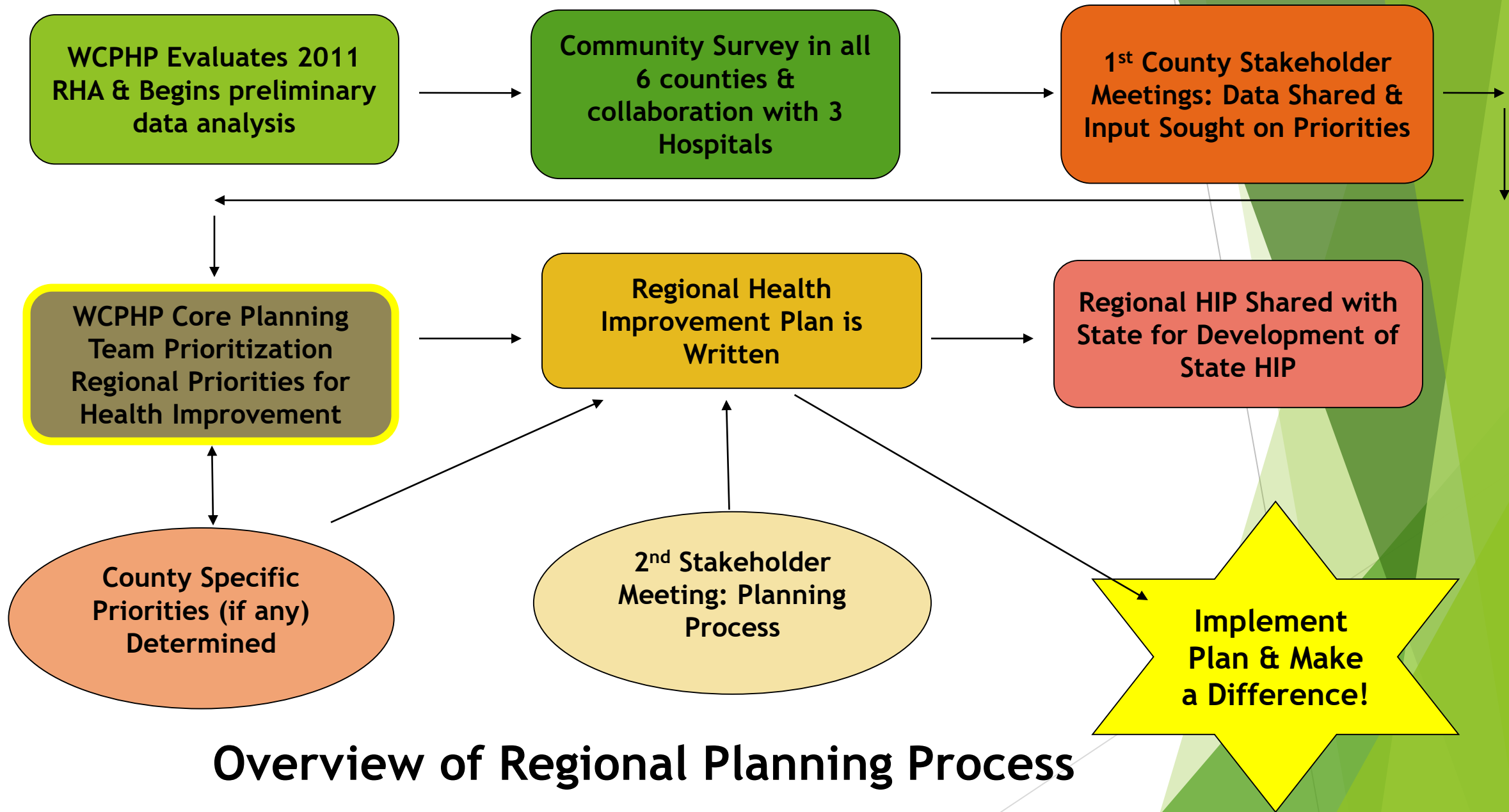

# Prioritization Goals

## ► Goal of Prioritization Process

- Data driven decision to select priority areas for WCPHP collaboration over next 5 years
- Areas ripe for impact
  - “The five-year goal is to “move the needle” on the issue, by either improving capacity or positively impacting a health outcome in a measurable way.”- CHAPS website
- Prioritization Matrix questions to guide process
  - Significance to Public Health
  - Ability to Impact
  - Capacity to Address the Issue
  - Prior Priority

# Definitions

- ▶ Priority- Health Concern
- ▶ Goal- Population level, broad based outcomes
- ▶ Strategy- Broad approach of how we are going to reach goal
  - ▶ Group of activities and tasks to achieve desired outcome

# Prioritization Process

1. Presented regional data to stakeholders in all six counties
2. Utilized Nominal Group Technique at stakeholder meetings to determine top health concerns in each county
3. Combined stakeholder meeting results using tool from OPPI

# Prioritization Process

4. Reviewed available data from hospital community health survey and stakeholder survey
5. Dec 15<sup>th</sup> WCPHP reviewed regional data, stakeholder meeting outcomes, hospital survey
6. Core WCPHP team selected six priorities to rank with the Prioritization Matrix

# Criteria/ Guidelines for Priorities

- ▶ Number of Goal Areas - (decided to wait to determine)
- ▶ Environmental Health - at least one Priority Area
- ▶ Health Issue vs. Strategy
- ▶ There is a Public Health Role for the issue
- ▶ Priority was identified by majority of region during Stakeholder Meetings
- ▶ OK to add one if Leadership team feels something vital is missing
- ▶ Prioritization Matrix Tool - Consensus to use tool
  - ▶ Discussion to follow on determining/using weight option if needed
  - ▶ Tool as a discussion process vs. absolute decision-maker

# Community Survey (n=473)

- ▶ **The top three health issues** rated as ‘major’
  1. Mental Health Issues (73.5%)
  2. Access to Mental Health/Substance Abuse Services (64.8%)
  3. Suicide/Suicide Attempts (62.7%)
- ▶ **The top three drug/substance abuse issues** rated as ‘major’
  1. Adult Substance Abuse (52.4%)
  2. Youth Drug Use (41.1%)
  3. Youth Alcohol Use (39.7%)
- ▶ **The top three community issues** rated as ‘major’
  1. Poverty (47.7%)
  2. Low Education Levels (29.6%)
  3. Transportation for Healthcare Purposes (24.4%)
